The Chairman, Dr.V.Sathyarekha chaired the meeting and welcomed all the members to the seventh BOS meeting. After the brief introduction, the agenda items listed were taken up for discussion and the following resolutions were passed after deliberation

1. As per the instructions from **TANSCHE and the Parent University**, it is resolved to include **75 % of mandatory inclusion** content from model syllabus and **25 % of Preferential inclusion** by our Department to preserve equivalence in U.G. and P.G. Degree Programmes to enable student Mobility to be implemented from the academic year 2023 – 2024 onwards is framed and restructured following the guidelines laid down by the UGC - LOCF and Tamil Nadu State Council for Higher Education (TANSCHE) and the Parent University.
2. Evaluate the Syllabus followed during the Academic Year 2022 – 2023 based on the first Semester Results.
3. Analyze the previous Curriculum based on the feedback received from the Teachers, Employers, Students and the Alumni.
4. Approve the Curriculum, Course Structure (Syllabi) and Text Books recommended for Implementation from 2023-2024 onwards.
5. In the present meeting the General Course Structure for the BBA programme and syllabus for the first two semesters were discussed and scrutinized for implementation from the academic year 2023-24 onwards based on the communication from the parent university/ TANSCHE.

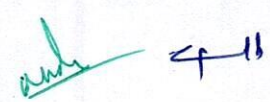


