1. As per the instructions from **TANSICHE and the Parent University**, it is resolved to include **75 % of mandatory inclusion** content from model syllabus and **25 % of Preferential inclusion** by our Department to preserve equivalence in U.G. and P.G. Degree Programmes to enable student Mobility to be implemented from the academic year 2023 – 2024 onwards .The courses are framed and restructured following the guidelines laid down by the UGC - LOCF and Tamil Nadu State Council for Higher Education (TANSICHE) and the Parent University.
